Secondly, the pre-proposal conference will only be conducted to explain the RFP procurement requirements.

In addition, GRTA amends Section 6: Proposal Structure, Subsection 6:6 Qualification to do Business on Page 12 of 47 as Amendment Number 3 which reads: The offerors must be licensed to conduct Transportation Management System Software and Hardware business on Guam at the time of proposal submission and must provide evidence of such license with their proposals. The offerors must also demonstrate that their subcontractors are licensed to conduct business on Guam. Failure to be properly licensed at the time of proposal submission or to provide evidence of licensure with the proposals is a ground for disqualification of the offerors. To now read as follows: The offerors are cautioned that GRTA will not consider for award any offer by an offeror and their subcontractor(s) who has not complied with the Guam Licensing Law.

Moreover, again to clarify, Section 2: Project Overview and Instructions, Subsection 2:3 pre-proposal questions and conferences, (c) pre-proposal conferences on page 3 of 4" as follows: the pre-proposal conference will only be conducted to explain the RFP procurement requirements. Also, on Item 3 of the Offeror's Checklist on Page iii pertains only to the above.
